

ORDINANCE NO. 136

AN ORDINANCE LAYING OUT AND OPENING HILLSIDE DRIVE FROM TOWNSHIP ROUTE NO. 710 TO THE SOUTHERLY SIDE OF DOGWOOD LANE, FARVIEW LANE FROM THE EASTERN SIDE OF HILLSIDE DRIVE EASTWARDLY A DISTANCE OF 349.5 FEET TO THE EASTERN SIDE OF ROGERS DRIVE, ROGERS DRIVE BETWEEN FARVIEW LANE AND DOGWOOD LANE, DOGWOOD LANE BETWEEN HILLSIDE DRIVE AND ROGERS DRIVE, AND RICHARDS LANE FROM HILLSIDE DRIVE WESTERLY 205 FEET TO LANDS OF FORREST SANDERCOCK AND RAYMOND HAHN, IN WASHINGTON TOWNSHIP, NORTHAMPTON COUNTY, PENNSYLVANIA

The Supervisors of the Township of Washington, Northampton County, Pennsylvania, in regular meeting assembled, being duly authorized to do so and having in all ways complied with the provisions of Section 1101 et seq. of The Second Class Township Code, as amended, do hereby enact and ordain that there are laid out and opened as public roads or streets within the Development known as Bettwood Place in said Township, the following:

(a) HILLSIDE DRIVE - Beginning at the northern intersection of Hillside Drive with Township Route No. 710, said point being 722.62 feet east of the eastern intersection of Township Route No. 710 with Township Route No. 708, thence along the center line of Hillside Drive North 26 degrees 15 minutes West 552.5 feet to the southerly side of Dogwood Lane, being of a uniform width of 33 feet throughout its entire length as aforestated.

(b) FARVIEW LANE - Beginning at a point of intersection of the center line of Hillside Drive with the center line of Farview Lane, said point being 166.5 feet north of Township Route No. 710 as measured along the center line of Hillside Drive, thence North 63 degrees 45 minutes East 349.5 feet to a point, the eastern side of Rogers Drive, and being of a uniform width of 33 feet throughout its entire length as aforestated.

(c) ROGERS DRIVE - Beginning at a point of intersection of the center line of Farview Lane with the center line of Rogers Drive, said point being 333 feet, more or less, from the center line of Hillside Drive, thence along the center line of Rogers Drive North 26 degrees 15 minutes West 380 feet, more or less, to a point, the center line of Dogwood Lane, being of a uniform width of 33 feet throughout its entire length as aforestated.

(d) DOGWOOD LANE - Beginning at a point on the western side of Hillside Drive, said point being 569 feet as measured along Hillside Drive from the center of Township Route No. 710, thence along the center line of Dogwood Lane North 65 degrees East 366 feet to the eastern side of Rogers Drive and being of a uniform width of 33 feet throughout its entire length as aforestated.

(e) RICHARDS LANE - Beginning at a point in the center of Hillside Drive, said point being 333 feet north from the center line of Township Route No. 710 as measured along Hillside Drive, thence South 63 degrees 45 minutes West 205 feet, more or less, to lands now or late of Forrest Sandercock and Raymond Hahn, and being of a uniform width of 33 feet, throughout its entire length as aforestated.

The location and width of said roads or streets, together with other relevant information concerning the improvements along the line thereof, as required by the Second Class Township Code, as amended, is set forth upon a map or survey made by David O. Pritchard, Township Engineer, entitled "Map showing roads to be ordained at Bettwood Place north of Route No. 710 near Ackermanville" dated November 1961 and filed with the Secretary of the Board of Supervisors.
