AN ORDINANCE RELATING TO THE MOVING OF HOUSEHOLD GOODS OR OTHER GOODS, WARES OR MERCHANDISE IN BULK INTO, FROM AND WITHIN THE LIMITS OF THE TOWNSHIP OF WASHINGTON, NORTHAMPTON COUNTY, PENNSYLVANIA, PROVIDING FOR ISSUANCE OF PERMITS THEREFOR AND PRESCRIBING THE FEE THEREFOR AND FIXING PENALTIES FOR THE VIOLATION THEREOF.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Washington Township, Northampton County, Pennsylvania, and it is hereby enacted and ordained by authority of the same:

SECTION 1: No person or persons, firm or corporation shall move or cause to be moved to any place within the Township of Washington or from any place therein to another place therein or beyond the limits thereof any household goods or other goods, wares or merchandise in bulk, without first securing from the Tax Collector of the Township of Washington a permit for such moving or transportation.

SECTION 2: Any person, firm, association, partnership or corporation, desiring such a permit for the removal or transportation of household goods in the manner above described, shall make application to the Tax Collector of the Township of Washington, on a form provided, setting forth: (1) his, its or their name and address, and the names of all members of the household, (2) the address from which the property is to be removed, and (3) the new address of the place to which the property is to be moved.

SECTION 3. The Tax Collector of the Township of Washington shall, upon application being made as provided in Section 2 above, and the payment of a fee of One (1.00) Dollar, payable to the Township of Washington, and after examination of the tax records to determine if all taxes are paid in full to date by the applicant, issue said moving permit, setting forth the name of the

permittee, date of issuance, the name of the owners of goods to be removed, the address from which and to which the same are being moved, moving date and mover. This permit shall be signed by the Tax Collector issuing the permit.

SECTION 4. Any person or persons violating the provisions of this Ordinance, or furnishing false information to the Tax Collector, or using false names or addresses, shall upon conviction thereof before the Justice of the Peace of the Township of Washington, be sentenced to pay a fine not exceeding One Hundred (\$100.00) Dollars or to undergo imprisonment not exceeding ten (10) days, or both.

SECTION 5. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section or part thereof not been included herein.

SECTION 6. This Ordinance shall be effective five (5) days after its adoption.
