FIFTH AMENDMENT TO ORDINANCE NO. 152

AN ORDINANCE ESTABLISHING THE POLICE PENSION FUND OF THE TOWNSHIP OF WASHINGTON, COUNTY OF NORTHAMPTON, AND COMMONWEALTH OF PENNSYLVANIA.

BE IT ENACTED AND ORDAINED by the authority of the Board of Supervisors of Washington Township, Northampton County, Pennsylvania, and it is hereby ordained and enacted by the same: SECTION 1: Pursuant to an Act of the General Assembly of Pennsylvania of May 12, 1943 P.L. 259, as supplemented and amended, the Police Pension Fund of the Township of Washington, hereinafter referred to as "Fund", is hereby established.

<u>SECTION 2</u>: The Fund shall be administered under the direction and management of the Board of Supervisors of Washington Township as Trustees.

SECTION 3: All life and health insurance benefits available to the participants in the Police Pension Fund shall be paid by the Township of Washington from its General Fund. No portion of the said life and health insurance benefits shall be paid in whole or in part from the funds designated as Police Pension Funds.

SECTION 4: All expenses of administration of the Fund, including the reasonable compensation of any actuary and the custodian of the Fund, shall be paid from the Fund and not by the Township of Washington.

SECTION 5: Authorization for the release of the payment of administrative and actuarial fees from the Fund shall be by recommendation of the Chief Administrative Officer for the Police Pension Fund and by Resolution of the Board of Supervisors of Washington Township.

SECTION 6: Vesting. After ten (10) years of credited service as a full time Police Officer of the Township of Washington, a member may file an application to vest by filing said application with the Chief Administrative Officer for the Police Pension Fund within ninety (90) days of separation from employment with the Township. Authorization for approval of said application for vesting shall be by recommendation of the Chief Administrative Officer for the Police Pension Fund and by Resolution of the Board of Supervisors of Washington Township. Under no circumstances shall vesting be permitted if said vesting would impair the actuarial soundness of the Police Pension Fund of Washington Township.

SECTION 7: Cost of Living Increase. Subject to recommendation by the Chief Administrative Officer, and subject to Resolution by the Board of Supervisors of Washington Township, all retirees under the Washington Township Police Pension Plan shall be entitled to cost of living increases for all benefits payable to members of the Police force receiving said retirement benefits. Provided, however, that said cost of living increase shall not exceed the percentage increase in the Consumer Price Index from the year in which the Police member last worked. Provided, further, that in

no case shall the total Police Pension benefits exceed seventy-five (75%) percentum of the salary for computing retirement benefits, and provided, further, that the total cost of living increase shall not exceed thirty (30%) percentum. Under no circumstances shall a cost of living increase be granted which would impair the actuarial soundness of the Police Pension Fund of Washington Township. Provided, further, that under no circumstances shall the cost of living increase in any given calendar or fiscal year exceed ONE THOUSAND AND 00/100 (\$1,000.00) DOLLARS on an annual basis. Any member of the police Eligibility For Benefits. SECTION 8: force who has served as a regular full time police officer for a minimum period of service not less than an aggregate of twenty (20) years for the Township of Washington, and shall have attained the age of at least fifty (50) years of age may retire from active duty, and such members as are retired shall be subject to service, from time to time, as a police reserve, in case of riot, tumult or preservation of the public peace until unfit for such service, when they may be finally discharged by reason of age or disability.

(a) Police officers who have served in this Township for an aggregate total of at least twenty (20) years and have attained the age of at least fifty (50) years and who, in the sole discretion of the Trustees, are determined to have become physically unfit for active duty;

Benefits from this Police Pension Fund may also be payable to:

(b) A police officer who, in the sole discretion of the Trustees, is determined to have become permanently disabled through no fault of his own while in the

performance of his duties as a police officer of this Township;

- (c) Police officers who, in the sole discretion of the Trustees, are determined to have become special cases of distress or necessity by reason of disability resulting from injury or illness other than connected with service; and
- (d) A widow and child, or children under eighteen (18) years of age, of a police officer whose death, in the sole discretion of the Trustees, is determined to have resulted from injuries received while in the performance of his duties as a police officer of this Township.

The determination by the Trustees in each case shall be based upon the submission of such evidence as the Trustees shall require. The determination of the Trustees in each case shall be final and conclusive.

SECTION 9: Insofar as the provisions of this Ordinance are the same as statutory provisions, they shall be subject to change or repeal to comply with any future statutory provisions and the provisions of this Ordinance may be amended or rescinded if statutory restrictions or mandates are eliminated and discretion vested in the Board of Supervisors of Washington Township.

SECTION 10: To the extent inconsistent with the amendments contained in this Fifth Amended Ordinance No. 152, the provisions of Ordinance No. 152 and amendments to Ordinance No. 152 are hereby repealed.

SECTION 11: This Ordinance shall be effective five (5) days after enactment hereof.

ORDINANCE NO. 152

AN ORDINANCE TO ESTABLISH A MUNICIPAL POLICE PENSION FUND FOR WASHINGTON TOWNSHIP, PROVIDING FOR THE REGULATION AND ADMINISTRATION THEREOF, ESTABLISHING BENEFITS, PROVIDING FOR CONTRIBUTIONS BY THE MEMBERS AND THE TOWNSHIP, FOR THE APPOINTMENT OF TRUSTEES AND AN ACTUARY AND FOR THE EXPENSES OF ADMINISTRATION.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Washington Township, Northampton County, Pennsylvania, that by authority of the same the Washington Township Police Pension Fund Ordinance is hereby adopted as follows:

SECTION 1. Establishment of Police Pension Fund.

A municipal police pension fund is hereby established by Washington Township as provided by the Act of May 29, 1956, P.L. 1804, 53 P.S. 767-778, and amended by the Act of July 10, 1957, P.L. 676, and the Act of September 15, 1961, P.L. 1342.

SECTION 2. Administration.

The Police Pension Fund shall be administered under the direction and management of the Board of Supervisors of Washington Township as Trustees. The Trustees may appoint a corporate fiduciary to act with them as a co-trustee. The trusts shall be managed and administred under an appropriate deed of trust to be prepared by the Township Solicitor and approved by the Township Supervisors. The trustees may also within their discretion purchase a pension annuity contract from a life insurance company authorized to do business in Pennsylvania, which may provide life insurance, pension, retirement and disability benefits to the policemen employed by the Township or to their dependents, provided that said contr

tract shall only cover full time Township policemen.

SECTION 3. Source of Funds.

The Police Pension Fund shall consist of such moneys as may be received from the Commonwealth of Pennsylvania by reason of the collection of taxes upon premiums paid by foreign casualty insurance companies for purposes of pension retirement for policemen; from appropriations made by the Township; from monthly payments made by members of the fund in an amount equal to not less than five (5%) per centum nor more than eight (8%) per centum of their monthly compensation, and from gifts, grants, devises or bequests to the fund.

SECTION 4. Eligibility for benefits.

Any member of the police force who has served as a regular full time police officer for a minimum period of service not less than an aggregate of twenty-five (25) years for the Township of Washington, and shall have attained the age of at least fifty-five (55) years may retire from active duty, and such members as are retired shall be subject to service, from time to time, as a police reserve, in case of riot, tumult or preservation of the public peace until unfitted for such service, when they may be finally discharged by reason of age or disability. However, police officers who have attained the age of sixty (60) years may retire after a period of total service of twenty (20) years. Benefits from this Police Pension Fund may also be payable to:

(a) Police officers who have served in this Township for an aggregate total of at least twenty (20) years and have attained the age of at least fifty (50) years and who, in the sole discretion of the Trustee are determined to have become physically unfit for active duty;

- (b) A police officer who, in the sole discretion of the Trustees, is determined to have become permanently disabled through no fault of his own while in the performance of his duties as a police officer of this Township;
- (c) Police officers who, in the sole discretion of the Trustees, are determined to have become special cases of distress or necessity by reason of disability resulting from injury or illness other than connected with service; and
- (d) A widow and child, or children under eighteen (18) years of age of a police officer whose death, in the sole discretion of the Trustees, is determined to have resulted from injuries received while in the performance of his duties as a police officer of this Township.

The determination by the Trustees in each case shall be based upon the submission of such evidence as the Trustees shall require. The determination of the Trustees in each case shall be final and conclusive.

SECTION 5. Benefits.

payments made under the provisions of this Ordinance shall not be a charge on any other fund in the treasury of the Township, or under its control, save the Police Pension Fund. The basis for determining any member of the force meeting the service and age qualifications of this Ordinance shall be as follows:

Monthly pension or retirement benefits shall be one-half the monthly average salary of such member during the last sixty (60) months of employment. Such pension or retirement benefits for any month shall be computed as the sum of (1) any pension benefits from pension plans heretofore established by a private organization or association for the members of

the police force, (2) primary benefits under Federal Social Security laws for which the officer may be eligible because of age, and (3) benefits from the Police Pension Fund established pursuant to this Ordinance to the extent necessary to bring the total benefits in any month up to one-half the aforesaid monthly average salary. In the case of the payment of pensions for permanent injuries incurred in service and to families of members killed in service, the amount and commencement of the payments shall be fixed by regulations of the said Board of Supervisors.)

SECTION 6. Employment of Actuary.

The Board of Supervisors may employ an actuary and may fix his compensation. The expenses of management and administration of the Police Pension Fund, including the compensation of the Trustees and the actuary, shall be paid by the Township.

SECTION 7. Refund.

Any member of the police force of the Township of Washington, who, for any reason whatsoever, shall be ineligible to receive a pension after having contributed to the Police Pension Fund, shall be entitled to a refund of all such moneys paid by him into such fund immediately upon discontinuance due to death, such moneys shall be paid to his designated beneficiary, in the manner directed by him, or in the absence thereof, to his estate.

SECTION 8. Credit for military service.

Any member of the police force who has been a regularly appointed employee of the Township of Washington for a period of at least six (6) months and who thereafter shall enter into the military service of the

United States, shall have credited to his employment record for pension or retirement benefits all of the time spent by him in such military service, if such person returns or has heretofore returned to his employment within six (6) months after his separation from the service.

SECTION 9. Validity.

Should any section or provision of this Ordinance be declared by any court of competent jurisdiction to be invalid, such decision shall not affect the validity of the Ordinance as a whole, or of any other part thereof.

SECTION 10. Effective Date.

This Ordinance shall become effective five (5) days after the enactment hereof.

Such pension or retirement benefits for any month shall be computed as the sum of (1) any pension benefits from pension plans heretofore established by a private organization or association for the members of the police force, (2) primary benefits under Federal Social Security laws for which the officer may be eligible because of age, and (3) benefits from the Police Pension Fund established pursuant to this Ordinance to the extent necessary to bring the total benefits in any month up to one-half the aforesaid monthly average salary. In the case of the payment of pensions for permanent injuries incurred in service and to families of members killed in service, the amount and commencement of the payments shall be fixed by regulations of the said Board of Supervisors.

SECTION 7(A) Upon the death of any policeman prior to his retirement, the Township shall pay to his beneficiary or to his estate, as the case may be, a lump sum death benefit in the amount provided by it in a life insurance contract on his life in effect at such time. In no event shall the beneficiary be entitled to receive, nor shall the Pension Fund be liable for payment of, more than the actual amount of the death benefits provided by said life insurance contract in force at the time of his death. Payment of such lump sum death benefit shall be in lieu of and constitute full satisfaction of the right of a member to receive monthly retirement benefits, as well as all other rights and interest of the participation in this fund. All such life insurance policies shall designate Washington Township

as its owner.

SECTION 8: Any payments herein provided for shall not be subject to attachment, execution, levy, garnishment, or other legal process and shall be payable only to the member or his designated beneficiary or beneficiaries and shall not be subject to assignment or transfer.

SECTION 9: Insofar as the provisions of this Ordinance are the same as statutory provisions, they shall be subject to change or repeal to comply with any future statutory provisions, and the provisions of this Ordinance may be amended or rescinded if statutory restrictions or mandates are eliminated and discretion vested in the Board of Supervisors.

This Ordinance shall be effective five (5) days after enactment thereof.

ORDINANCE NO. 152

AN ORDINANCE ESTABLISHING THE POLICE PENSION FUND OF THE TOWNSHIP OF WASHINGTON, COUNTY OF NORTHAMPTON, COMMONWEALTH OF PENNSYLVANIA.

BE IT ORDAINED AND ENACTED by the authority of the Supervisors of the Township of Washington and it is hereby ordained and enacted by the same:

SECTION 1: Pursuant to an Act of the General Assembly of Pennsylvania of May 12, 1943 P.L. 259, as supplemented and amended, the Police Pension Fund of the Township of Washington, hereinafter referred to as "Fund", is hereby established.

SECTION 2: The Fund shall be administered under the direction and management of the Board of Supervisors of Washington Township as Trustees.

SECTION 3: All life and health insurance benefits available to the participants in the Police Pension Fund shall be paid by the Township of Washington from its General Fund. No portion of the said life and health insurance benefits shall be paid in whole or in part from the funds designated as Police Pension Funds.

SECTION 4: All expenses of administration of the Fund, including the reasonable compensation of an actuary and the custodian of the fund, shall be paid from the Fund and not by the Township of Washington.

SECTION 5: Authorization for the release of the payment of administrative and actuarial fees from the fund shall be by recommendation of the Chief Administrative Officer for the Police Pension Fund and by Resolution of the Board of Supervisors of Washington Township.

SECTION 6: Insofar as the provisions of this Ordinance are the same as statutory provisions, they shall be subject to change or repeal to comply with any future statutory provisions and the provisions of this Ordinance may be amended or rescinded if statutory restrictions or mandates are eliminated and discretion vested in the Board of Supervisors.

SECTION 7: To the extent inconsistent with the amendments contained in this Second Amended Ordinance No. 152, the Provisions of Ordinance No. 152 and Amended Ordinance No. 152 are hereby repealed.

SECTION 8: This Ordinance shall be effective five (5) days after enactment thereof.

FIFTH AMENDMENT TO ORDINANCE NO. 152

AN ORDINANCE ESTABLISHING THE POLICE PENSION FUND OF THE TOWNSHIP OF WASHINGTON, COUNTY OF NORTHAMPTON, AND COMMONWEALTH OF PENNSYLVANIA.

BE IT ENACTED AND ORDAINED by the authority of the Board of Supervisors of Washington Township, Northampton County, Pennsylvania, and it is hereby ordained and enacted by the same:

SECTION 1: Pursuant to an Act of the General Assembly of Pennsylvania of May 12, 1943 P.L. 259, as supplemented and amended, the Police Pension Fund of the Township of Washington, hereinafter referred to as "Fund", is hereby established.

SECTION 2: The Fund shall be administered under the direction and management of the Board of Supervisors of Washington Township as Trustees.

SECTION 3: All life and health insurance benefits available to the participants in the Police Pension Fund shall be paid by the Township of Washington from its General Fund. No portion of the said life and health insurance benefits shall be paid in whole or in part from the funds designated as Police Pension Funds.

SECTION 4: All expenses of administration of the Fund, including the reasonable compensation of any actuary and the custodian of the Fund, shall be paid from the Fund and not by the Township of Washington.

SECTION 5: Authorization for the release of the payment of administrative and actuarial fees from the Fund shall be by recommendation of the Chief Administrative Officer for the Police Pension Fund and by Resolution of the Board of Supervisors of Washington Township.

SECTION 6: Vesting. After ten (10) years of credited service as a full time Police Officer of the Township of Washington, a member may file an application to vest by filing said application with the Chief Administrative Officer for the Police Pension Fund within ninety (90) days of separation from employment with the Township. Authorization for approval of said application for vesting shall be by recommendation of the Chief Administrative Officer for the Police Pension Fund and by Resolution of the Board of Supervisors of Washington Township. Under no circumstances shall vesting be permitted if said vesting would impair the actuarial soundness of the Police Pension Fund of Washington Township.

SECTION 7: Cost of Living Increase. Subject to recommendation by the Chief Administrative Officer, and subject to Resolution by the Board of Supervisors of Washington Township, all retirees under the Washington Township Police Pension Plan shall be entitled to cost of living increases for all benefits payable to members of the Police force receiving said retirement benefits. Provided, however, that said cost of living increase shall not exceed the percentage increase in the Consumer Price Index from the year in which the Police member last worked. Provided, further, that in

no case shall the total Police Pension benefits exceed seventy-five (75%) percentum of the salary for computing retirement benefits, and provided, further, that the total cost of living increase shall not exceed thirty (30%) percentum. Under no circumstances shall a cost of living increase be granted which would impair the actuarial soundness of the Police Pension Fund of Washington Township. Provided, further, that under no circumstances shall the cost of living increase in any given calendar or fiscal year exceed ONE THOUSAND AND 00/100 (\$1,000.00) DOLLARS on an annual basis. Eligibility For Benefits. Any member of the police SECTION 8: force who has served as a regular full time police officer for a minimum period of service not less than an aggregate of twenty (20) years for the Township of Washington, and shall have attained the age of at least fifty (50) years of age may retire from active duty, and such members as are retired shall be subject to service, from time to time, as a police reserve, in case of riot, tumult or preservation of the public peace until unfit for such service, when they may be finally discharged by reason of age or disability. Benefits from this Police Pension Fund may also be payable to:

- (a) Police officers who have served in this Township for an aggregate total of at least twenty (20) years and have attained the age of at least fifty (50) years and who, in the sole discretion of the Trustees, are determined to have become physically unfit for active duty;
- (b) A police officer who, in the sole discretion of the Trustees, is determined to have become permanently disabled through no fault of his own while in the

performance of his duties as a police officer of this Township;

- (c) Police officers who, in the sole discretion of the Trustees, are determined to have become special cases of distress or necessity by reason of disability resulting from injury or illness other than connected with service; and
- (d) A widow and child, or children under eighteen (18) years of age, of a police officer whose death, in the sole discretion of the Trustees, is determined to have resulted from injuries received while in the performance of his duties as a police officer of this Township.

The determination by the Trustees in each case shall be based upon the submission of such evidence as the Trustees shall require. The determination of the Trustees in each case shall be final and conclusive.

SECTION 9: Insofar as the provisions of this Ordinance are the same as statutory provisions, they shall be subject to change or repeal to comply with any future statutory provisions and the provisions of this Ordinance may be amended or rescinded if statutory restrictions or mandates are eliminated and discretion vested in the Board of Supervisors of Washington Township.

SECTION 10: To the extent inconsistent with the amendments contained in this Fifth Amended Ordinance No. 152, the provisions of Ordinance No. 152 and amendments to Ordinance No. 152 are hereby repealed.

SECTION 11: This Ordinance shall be effective five (5) days after enactment hereof.
