ORDINANCE NO. 189

AN ORDINANCE OF WASHINGTON TOWNSHIP, NORTHAMPTON COUNTY, COMMONWEALTH OF PENNSYLVANIA, AMENDING ORDINANCE NO. 167, LIMITING THE MAXIMUM COMPENSATION THE WASHINGTON TOWNSHIP BOARD OF SUPERVISORS MAY ANNUALLY RECEIVE FROM THE GENERAL TOWNSHIP FUND.

WHEREAS, the Township of Washington has heretofore enacted Ordinance No. 167 on December 30, 1985, which establishes the maximum compensation the Board of Supervisors may annually receive; and

WHEREAS, the Board of Supervisors are desirous of amending the aforementioned Ordinance; and

WHEREAS, the Board of Supervisors are further desirous of re-establishing the annual rate of compensation that the Supervisors may receive on an annual basis to be in strict compliance with the Second Class Township Code.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of Washington Township, County of Northampton and Commonwealth of Pennsylvania, as follows:

1. Each Supervisor of Washington Township elected or appointed to office on or after November 7, 1995 shall receive

compensation for attending duly advertised general or special public meetings of the Board of Supervisors at an annual rate of compensation to be in strict compliance with Section 515(a) of the Second Class Township Code, as amended. For purposes of this paragraph, the rate established by the State Legislature for annual compensation of the Board of Supervisors shall be deemed to be an annual salary.

- 2. No Supervisor shall receive annual compensation under this Ordinance in excess of the annual Statutory limit set by the General Assembly for Supervisors of Townships of the Second Class with a population category equal to that of the Township of Washington.
- Each Supervisor's compensation shall be paid monthly.
- 4. In the event that the aforementioned Section 515 of the Second Class Township Code shall be amended in the future by the State Legislature, the rate of compensation then established, by amendment, by the said State Legislature, shall be applicable to the rate of compensation due and owing to the Board of Supervisors. In such case, no further amendment of this Ordinance shall be required to establish the annual rate of compensation for each member of the Board of Supervisors.

5. This Ordinance shall be effective upon adoption.
