ORDINANCE NO. 279

AN ORDINANCE OF THE TOWNSHIP OF WASHINGTON  
AMENDING ORDINANCE NO. 211, AND PROVIDING FOR ALTERNATE  
MEMBERSHIP IN THE WASHINGTON TOWNSHIP RECREATION BOARD.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of  
Washington Township, Northampton County, Pennsylvania, and it is hereby  
enacted and ordained by the authority of the same, as follows:

Section 1: Section 2 of Ordinance No. 211 enacted on October 13, 1999,  
is hereby amended as follow:

Section 2: Terms of Office, Filling of Vacancies, and Compensation:  
The Washington Township Recreation Board shall consist of seven (7) members,  
and no more than two (2) alternate members, who shall not be voting members  
of the board unless called upon to serve in the absence of regular Board  
members. Regular Board members shall be appointed by the Board of  
Supervisors of the Township to serve for a term of five (5) years, or until their  
successors are appointed, except for the terms of the members of said Board first  
appointed hereunder. With regard to the members of said Board first appointed,

two (2) members shall be appointed for a term of one (1) year; two (2) members shall be appointed for a term of two (2) years; one (1) member shall be appointed for a term of three (3) years; one (1) member shall be appointed for a term of four (4) years; and one (1) member shall be appointed for a term of five (5) years. At the expiration of the terms of each of the members of said Board first appointed hereunder, a successor shall be appointed by the Board of Supervisors of the Township of Washington to serve for a term of five (5) years. Alternates shall serve for a period of one (1) year. Vacancies in said Board occurring otherwise than by expiration of term shall be filled for the unexpired term in the same manner as original appointees. Members of the Recreation Board shall serve without compensation.

Section 3: All other provisions of Ordinance No. 211 shall remain in full force and effect.


Section 4: This Ordinance shall be placed into effect immediately upon enactment hereof.


Washington Township Recreation Board shall be required to make full and complete reports, including, but not limited to financial reports, to the Washington Township Board of Supervisors.
