Welcome to Your Dog Park Park Rules



- Dogs must be at least 4 months of age, vaccinated, and licensed to enter the park.
- Do not enter if your dog is in heat, aggressive, or sick.
- The dog park is divided into 2 sections: one for small dogs (30 pounds or less), and one for large dogs (over 30 pounds). Use the appropriate section of the park for your dog size.
- Owners must be in the park and always supervising their pets.
- Keep all gates closed to prevent escape attempts.
- Outside of the dog park, all dogs must be leashed.
- Use the dog park at your own risk. Owners are solely liable for their pets' actions.
- No smoking, food, or glass containers are allowed in the dog park.
- Owners must pick up and dispose of their pets' waste.
- Please report any problems to the Washington Township Administrative Office.
